

Iowa Business Council to launch “Vision to Vitality” community forums July 17 in Boone

Quarterly forums will feature a panel with IBC member CEOs and a discussion on how local communities approach business and growth challenges

(DES MOINES) – The Iowa Business Council (IBC) announced a new series of community forums titled “Vision to Vitality.” The Vision to Vitality forums, which will be held quarterly across the state, will feature the IBC’s executive director Georgia Van Gundy and select IBC member CEOs. The Vision to Vitality forum series will launch July 17, 2018, in Boone, Iowa. The event will take place at DMACC Boone Campus Theatre from 4:00 – 5:30 p.m.

The forums will include a candid discussion with CEOs from some of Iowa’s largest employers about the state of Iowa’s economy, provide insight into the regional, state and local business climates, and examine how their local communities and industries are approaching today’s business challenges. The event will also offer an opportunity for the IBC to hear from attendees about what policies could help communities grow and thrive. The events will be free to attend and open to both the public and the media.

“The mission of the IBC is to develop policies and initiatives that serve as a catalyst for economic growth in Iowa. Our member CEOs’ expertise, along with our unique research and data, is what positions our organization to elevate Iowa’s long-term economic vitality,” said Ruan Transportation Management Systems CEO Benjamin J. McLean, who serves as the Iowa Business Council chairman. “For Iowa to continue its economic growth, Iowa Business Council members understand that we need to foster local collaboration and share best-practices within local communities. Our new ‘Vision to Vitality’ forums will be community conversations that allow all of us to work together and discuss how to transform a vision of growth into reality.”

The first Vision to Vitality forum will be hosted by Fareway Stores in Boone, where the company is headquartered. Fareway Stores CEO Reynolds Cramer will be the event’s featured chief executive. The forum will include a panel discussion on current workforce development efforts, like Boone EDGE, and discuss challenges to growth that the Boone area must address as a community. The panel will be followed by an open discussion period where the IBC will gather feedback from the attending community members regarding their workforce challenges and their best practices.
